TOWN ENGINEER

Marcelin Joseph, was not present

SEWER & WATER

Mr. Charles Carter, Maintenance Supervisor, told the Council that they had bee fixing water leaks and cleaning ditches. Mr Carter also stated that at some point the Parish will need to be involved so that the drainage water can move out of town and into designated bayous and canals. Mr. Carter also said that issues with brown water in the water system were mainly due to a phosphate pump being down. The pump has since been replaced. Phosphate binds to the iron and magnesium in the water and keeps the water from taking on a brownish color. He also said the sewer plant needed some repairs and is operating at about 45% capacity.

STREETS & DRAINAGE

Town Maintenance worker Dana Smith said that they are waiting for the ground to dry more before attempting to cut the tall weeds at Canadaville.

FIRE DEPARTMENT

Fire Chief Dana Smith told the Council that fire department would be hosting a Bingo and gumbo on Saturday, January 15, 2022.

POLICE DEPARTMENT

Chief Daniel Firmin told the Council that a total of 77 violations with 5 arrests made. Chief Firmin said that he replaced the tires on the Ford Explorer. Also, officer Jamshad Fayyaz graduated the police academy and is now fully POST Council certified. He also received the academy's Staff Choice award for his dedication to his training. Councilwoman Kennedy also asked for a roster of police officers.

TOWN CLERK

Town Clerk Dacia Adams told the council that the auditors were on site the past week. They scheduled for 3-days, but the on-site visit only required two days. The audit exit report should be ready by the end of the month. Mrs. Adams also said that occupational licenses were due and the application can be picked up at the Town Hall or can be down loaded from the Town of Simmesport's webpage under the Town Clerk's page.

TOWN ATTORNEY/MAGISTRATE

Attorney LaCour said that there was a productive court at the end of December with a good turnout. He also informed the council that the lawsuit that was outstanding was moved from Baton Rouge to the U.S. District Court in Lafayatte.
