AGENDA ITEM 5: PROPOSAL FOR VFW/BUILDING

Mayor Draper and Town Attorney LaCour presented an agreement to the Council for the Simmesport VFW's use of the Town-owned building on Norwood St. Attorney LaCour explained that the Town of Simmesport cannot give way property or services to anyone. An agreement was drafted and presented to the Simmesport VFW where the post would pay \$1 per year along with in-kind services for a term of 99 years. The post would also have to pay the utilities to the building and the insurance on the building. Mayor Draper said the post did not agree with this offer. A new offer was drafted by the Town of Simmesport whereby the Town would continue to upkeep the insurance on the building but this would not include the personal effects of the VFW.

AGENDA ITEM 7: PROPOSAL FOR POLICE VEHICLE/UNITS

Mayor Draper and Chief Firmin found a program where the town could lease new police units for \$6,000 per year per vehicle. The provides for 32,000 miles per year and at the end of the year the vehicles are turned in and replaced with a new vehicle. The leasing agency is responsible for all maintenance with the exception of tire changes and routine oil and filter changes. Chief Firmin did add that each car would cost approximately \$7,000 to equip with lights, electronics, radios and cages. Those items can be removed and placed in the new units. Alderwoman Kennedy asked Mayor Draper if the budget would allow for this purchase. Mayor Draper assured the council that the budget could accommodate this especially since the current units are costing approximately \$2,500 per month for repairs.
