AGENDA ITEM 10: DEPARTMENT REPORTS

MAINTENANCE SUPERVISOR: DANA SMITH

Mr. Smith said that all water leaks were fixed with the exception of the line crossing a bayou between North Martin Luther King Dr. and Clark St. Mayor Draper said that he spoke with Police Juror Jacob Coco and the police jury may be able to help repair that line.

SEWER PLANT

Mr. Carter said the additions and upgrades to the sewer plant are still planned to begin in July. He also reported that heavy rains will cause the sewer system to overload and people may experience slowly flushing toilets.

STREET DEPARTMENT

Dana Smith said the crew is trying to keep up with grass cuttings between the rains and filling potholes.

FIRE DEPARTMENT

Fire Chief Dana Smith told those assembled that Fire Department's annual chicken dinner and Bingo went well. He also said that the new fire truck will be delivered in September.

POLICE DEPARTMENT

Police Chief Daniel Firmin said there were 63 tickets written resulting in 94 violations 25 reports filed with 6 arrests. \$6,837.10 were collected in fines. He also reported that two cars were down, one with a crankshaft bearing.

TOWN CLERK

Jalesia Batiste told the Council that the office staff has really been concentrating on delinquent utility accounts and completing the cutoff list. Mrs. Batiste also said she has been in communication with all of the vendors, that she is aware of, that we owed money to. Day-to-day operations have returned to normal as Mrs. Batiste settles into the role of Town Clerk.

TOWN ATTORNEY/MAGISTRATE

Town Attorney Kirk LaCour informed the council there are still two lawsuits with one negotiating a possible settlement. The other is in discovery although a motion for summary judgement has been filed on some issues. Attorney Lacour said that the Magistrate Court is running well and attendance is up.
