ORDINANCE NO. 12-2020-01

AN ORDINNACE TO ESTABLISH SALARY AND COMPENSATION FOR THE MAYOR, TOWN CLERK, CHIEF OF POLICE, MAINTENANCE SUPERVISOR, AND MEMBERS OF THE TOWN COUNCIL

Whereas, the Mayor, Town Clerk, Chief of Police, Maintenance Superintendent and Members of the Town Council must be compensated appropriately for the performance of their duties and their respective positions, whether elected or appointed, for the Town of Simmesport;

Whereas, Louisiana Revised Statute (La. R.S.) 33:404.1 requires the Board of Aldermen to fix compensation of the mayor, aldermen, clerk, and chief of police by ordinance;

Whereas, the Town Council of the Town of Simmesport finds that it is unclear when or how current compensation for these positions was set or approved, and;

Whereas, the Town Council of the Town of Simmesport understands it is their duty to set and approve compensation for these positions.

NOW, therefore, the Town Council for the Town of Simmesport sets the salary and compensation for the positions of Mayor, Town Clerk, Chief of Police, Maintenance Supervisor, and Members of the Town Council as follows:

Mayor	Salary: Twenty-Seven Thousand Dollars (\$27,000.00) per year paid in monthly installments totaling Two Thousand Two Hundred Fifty Dollars (\$2,250.00) each month plus reimbursement of any expenses approved by the mayor, or by majority vote of the Town Council, for expenses incurred during the course and scope of a Council Member's duties to the municipality.
Town Clerk	Salary: Thirty-Eight Thousand Four Hundred Eighty Dollars (\$38,480.00) per year paid in monthly installments totaling Three Thousand Two Hundred Six and 67/100 Dollars (\$3,206.67) each month plus reimbursement of any expenses approved by the mayor, or by majority vote of the Town Council, for expenses incurred during the course and scope of a Council Member's duties to the municipality.
Chief of Police	Salary: Thirty-Eight Thousand Four Hundred Dollars (\$38,400.00) per year paid in monthly installments totaling Three Thousand Two Hundred Dollars (\$3,200.00) each month plus reimbursement of any expenses approved by the mayor, or by majority vote of the Town
