AGENDA ITEMS 9: ORDINANCE 10-2025-03: AN ORDINANCE TO ESTABLISH PROCEDURES FOR EMPLOYEE TIME KEEPING

Attorney LaCour said that there was an incorrect statement of law in the text of the ordinance. Attorney LaCour also said that the proposed ordinance, because it deals with employee time, is fiscal in nature and therefore infringes upon the Fiscal Administrator's duties.

AGENDA ITEM 10: ORDINANCE 10-2025-04: AN ORDINANCE TO COORDINATE WITH THE LOUISIANA STATE POLICE FOR VIOLENT CRIMES COMMITTED WITHIN TOWN LIMITS

Attorney LaCour stated that the Louisiana State Police will determine on a case-by-case basis whether or not they will accept the case to investigate. Attorney LaCour also stated that a certified detective, Mansura Police Chief John Johnson, was contracted by the Town of Simmesport to be the detective. Councilman Patrick Wright, presiding, stated that if the State Police are called, they will come. Attorney LaCour stated he spoke to the District Attorney and the DA said the State Police determine if they will investigate a case. Attorney LaCour said that the Town of Simmesport cannot require the State Police to take any case.

Alderman Wright, presiding, wanted to know who moved the small building from Yellow Bayou Park to the Town Hall. Attorney LaCour stated that the Mobile Home ordinance did not apply to this building because it was Town property. Alderman Bell said that the Council did not approve the expenditure for moving the building. Attorney LaCour said the cost was approved by the fiscal administrator. Alderman Dauzat stated that he wanted to make certain the Ordinance was enforced. Town employee Rene Whtimore stated that the ordinance probably needed to be amended to make the process more clear as to what the trailer owner needs to do and what the Town is required to do. Alderman Dauzat suggested the Council form a committee to determine what changes needed to be made to the ordinance.

AGENDA ITEM 13: DEPARTMENT UPDATES

A. FISCAL ADMINISTRATOR UPDATE: Joel Robideaux – absent

B. UTILITY DEPARTMENT STREETS

Mr. Dana Smith reported that the water valve to Riverside Elementary School has been repaired.

C. SEWER DEPARTMENT

D. ENGINEERS: DELTA ENGINEERING

Marcus Guillory from Delta Engineering Group addressed the council and said they were looking for grant opportunities to help repair and upgrade infrastructure. Marcus said they worked with Representative Deshotel's office to get \$25,000 to replace pumps at the sewer plant. They also said they worked on a water leak survey which resulted in a project of approximately \$330,000 that has been submitted to the State. He said they also put in a Capital Outlay request for the water leaks. Marcus also said they are planning to apply for money through the Water Sector Program to address both water and sewer issues. Mr. Guillory also recommended we apply for the LGAP and CWEF grants, which are smaller, but can be used to address certain problems. The Council thanked Mr. Guillory and Delta Engineering for their help and work on these projects.

E. FIRE DEPARTMENT

Ms. Karen Gautreaux said the substation is on hold for a short time.

F. POLICE DEPARTMENT

Attorney LaCour said outstanding case files are being finished up and are near ready to submit to the District Attorney.

G. TOWN CLERK

Mrs. Tonya Terrell went through the October disconnect list. She said that the initial list had 169 people on the cut-off list. The Town put out door hangers and removed the people on payment plans. By doing this the Town was able to remove all but 58 people from the cutoff list. The total utilities collected for the month of October was \$41, 294.51.

H. TOWN ATTORNEY

Attorney LaCour said that the docket for the November Court will be large. He also said that because of the Thanksgiving Holiday, court will be held on November 17. There are currently no outstanding lawsuits.. Alderman Dauzat asked about the sale of the piece of Town property to the newly opened clinic. Attorney LaCour said he has not heard anything from the owners of the clinic. Alderman Dauzat also asked if there had been progress on an agreement with the Police Jury litter enforcement. Attorney LaCour said he had not received anything from the Police Jury. Mr. LaCour said that the consensus among the Council at the last meeting was that the litter cases were to be heard in Simmesport so that any fines or court costs would go to Simmesport.
