E. FIRE DEPARTMENT

Mr. Eric Rusk gave an update on the new fire station. Mr. Ruck also said that the next Saturday at 2 PM there will be an event for the children at the fire station.

F. POLICE DEPARTMENT

Officer Boulland said the officers are patrolling as usual. He also stated that the Christmas Train event went off without a hitch and thanked the other agencies for their help.

G. TOWN CLERK

Ms. Gwen Barr said we received a notice from the IRS that there were unpaid taxes from 2023 and 2024. She said that Mr. Robideaux and Town Attorney Kirk LaCour were handling the situation and that Kirk LaCour had power of attorney for the Town of Simmesport. A meeting will be held with the IRS in Alexandria to find out details and work on paying these back taxes. Ms. Barr also said that the former administration signed a 5-year contract with Axon for body cams and TASERS. The contract was for \$13,344 annually. However, years 3, 4, and 5 were never paid. Ms. Barr said Mr. Robideaux and Attorney LaCour were addressing this situation with Axon. Utility Clerk Tonya Terrell said the disconnect list was down to 42 people this month. Last month was the first month cutoffs were done in the same month the bills were sent out.
